## **Gymnastics Birthday Parties Terms and Conditions**

By making a booking for a 'Gymnastics Birthday Party' (**Party**) at the Centre, you acknowledge and agree:

- 1. that the Party, has been, or will be booked by you at least 2 weeks prior to the date of the Party;
- that each participant of the Party will be aged 3 years or older at the date of the Party;
- 3. that you will pay us a minimum, non-refundable, deposit equivalent to the price of 12 participants (the **Deposit**) at, or around, the time of the booking;
- 4. that if you exceed 12 participants, you agree to pay an additional fee equivalent to the sum of price per participant for each of the additional participants;
- 5. that you will limit the number of attendees at the Party to no more than 24 participants;
- 6. that you will provide confirmation of numbers to <a href="mailto:gymnastics@mq.edu.au">gymnastics@mq.edu.au</a> by 5pm the Thursday prior to the Party, followed by payment in full. No additional attendees can join on the day of the party;
- 7. the Party will be limited to a period of 2 hours in duration, or as otherwise set out in the booking, with the Party to occur at the date and time set out in the booking;
- 8. no refund will apply in respect of any non-attendance or under-attendance at the Party;
- 9. that you have had the opportunity to read, and that you agree to be bound by and ensure that the participants comply with the Macquarie University Sport & Aquatic Centre conditions of entry, available at the following link: <u>Conditions of Entry</u>
- 10. that we have raised the following 'risk warning' with you, and you agree that:
  - a. participation in the activities offered at the Centre are considered 'recreational activities' or 'dangerous recreational activities' as those terms are defined in the Civil Liability Act 2002 (NSW); and
  - b. participation in the recreational activities (including the Party) involves a general risk of harm that may result in loss or damage to participants, including the risk of personal injury and death.
  - The sources of the risk of harm include, (but are not limited to):
    i.impacts from equipment, poor, wet or slippery surfaces, physical exertion, intentional or accidental contact or collisions with other patrons;
    - ii.disparity in experience or condition of participants, disparity in maturity or competitiveness of participants;
  - d. you are the responsible person for all participants under 18 years of age (each a **Child**, and together the **Children**) at the date of the Party, and you have obtained consent of the relevant legal guardian for each Child to participate in the Party at the Centre.
  - e. you acknowledge, agree, and understand that participation in any recreational activities may involve risk. You agree and undertake responsibility on behalf of the relevant Children in respect for any of such risk voluntarily and at your own risk. You acknowledge that the assumption of risk and warning above constitutes a 'risk warning' in accordance with relevant legislation.

Customers are required to assemble in the Gymnastics foyer area prior to the commencement of the party and exit the party room no later than 10 minutes after the conclusion of the party.
